The Federal Emergency Management Agency (FEMA) has activated Emergency Support Function 4 (ESF4) to assist with the wildfires burning in Hawaii.

One incident management team and two overhead personnel are assigned to large fire support in Canada.

One MAFFS C-130 airtanker and support personnel from the 153rd Airlift Wing (Wyoming Air National Guard) and one MAFFS unit from the 152nd Airlift Wing (Nevada Air National Guard) have been deployed to Klamath Falls, OR to support wildland fire operations nationally.

Happy Camp Complex, (6 fires), Klamath NF, USFS. IMT 1 (CA Team 5). Twenty-one miles west of Yreka, CA. Timber and brush. Community of Hamburg and infrastructure threatened. Evacuations, road and trail closures in effect.

2023 SRF Lightning Complex, (7 fires), Six Rivers NF, USFS. IMT 1 (CA Team 2) mobilizing. Twenty-two miles north of Hoopa, CA. Timber and brush. Moderate fire behavior with flanking, backing and spotting. Numerous structures threatened.

Smith River Complex, (6 fires), Six Rivers NF, USFS. IMT 2 (CA Team 15). Seven miles northeast of Gasquet, CA. Timber and brush. Active fire behavior with backing, torching and spotting. Several communities, and infrastructure threatened. Evacuations, area, road and trail closures in effect.

South Fork Complex, (2 fires), Shasta-Trinity NF, USFS. IMT 2 (CA Team 11). Includes the previously reported Pilot fire. Fifteen miles west of Hayfork, CA. Timber and brush. Active fire behavior with short crown runs, group torching and short-range spotting. Communities of Hyampom and Lake Mountain Ranch and infrastructure threatened. Area, road and trail closures in effect.

Deep, Shasta-Trinity NF, USFS. IMT 2 (CA Team 10). Ten miles north of Weaverville, CA. Brush and timber. Active fire behavior with backing, torching and short-range spotting. Structures threatened. Evacuations, area and trail closures in effect.

* **Lake**, Klamath NF, USFS. Twelve miles northwest of Greenview, CA. Timber and brush. Active fire behavior with group torching, short crown runs and short-range spotting. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

SKU August Lightning Complex, Siskiyou Unit, Cal Fire. Two miles south of Yreka, CA. Timber and brush. Moderate fire behavior with backing, creeping and smoldering. Energy infrastructure threatened.

Slide 1, Mendocino NF, USFS. Twenty-four miles northwest of Flournoy, CA. Chaparral, grass and timber. Minimal fire behavior with creeping and flanking. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Lahaina, County of Maui. One mile northeast of Lahaina, HI. Grass and brush. Minimal fire behavior. Several communities threatened. Area and road closures in effect.

Upcountry, County of Maui. Eight miles northeast of Wailea, HI. Grass and brush. Minimal fire behavior. Several communities threatened. Area and road closures in effect.

Lookout, Willamette NF, USFS. IMT 2 (NW Team 6). Four miles north of McKenzie Bridge, OR. Timber. Active fire behavior with uphill runs, group torching and short-range spotting. Community of McKenzie Bridge and infrastructure threatened. Evacuations, area, road and trail closures in effect.

Bedrock, Willamette NF, USFS. Transfer of command from IMT 2 (NW Team 12) to IMT 1 (NW Team 2) will occur tomorrow. IMT is also managing the Salmon fire. Twelve miles south of Vida, OR. Timber and brush. Active fire behavior with torching, uphill runs and short crown runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Salmon, Willamette NF, USFS. Four miles northeast of Oakridge, OR. Timber and brush. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

Sourdough, North Cascades NP, NPS. Transfer of command from IMT 2 (NW Team 10) to IMT 2 (NW Team 8) will occur tomorrow. Six miles northeast of Newhalem, WA. Timber and brush. Active fire behavior with uphill runs and torching. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Flat, Rogue River-Siskiyou NF, USFS. IMT 2 (SW Team 3). Two miles southeast of Agness, OR. Brush, timber and chaparral. Moderate fire behavior with backing, isolated torching and smoldering. Structures threatened. Area, road and trail closures in effect.

* **Winona**, Washington State Fire Marshal's Office. Twenty-one miles northwest of Colfax, WA. Grass and brush. Extreme fire behavior with wind-driven runs. Numerous structures threatened. Evacuations, area and road closures in effect.

* **Gray**, Northeast Region-Department of Natural Resources. Three miles southwest of Medical Lake, WA. Timber, grass and brush. Extreme fire behavior with wind-driven runs, crowning and long-range spotting. Several communities and infrastructure threatened. Evacuations, area and road closures in effect.

Wiley, Willamette NF, USFS. Started on private land 10 miles southeast of Sweet Home, OR. Timber. Minimal fire behavior with smoldering and creeping. Road closures in effect.

East Fork, Kootenai NF, USFS. CIMT (NR Team 6). Twelve miles south of Trego, MT. Timber. Active fire behavior with wind-driven runs, group torching and spotting. Numerous residences threatened. Evacuations and road closures in effect.

Ridge, Flathead NF, USFS. IMT 1 (CA Team 4). IMT 1 (SW Team 1) mobilizing. IMT is also managing the Tin Soldier Complex and Doris Point fires. Six miles east of Hungry Horse, MT. Timber and brush. Active fire behavior with short crown runs, creeping and smoldering. Residences and communication infrastructure threatened. Area and road closures in effect. Precipitation occurred over the fire area yesterday.

Tin Soldier Complex, (3 fires), Flathead NF, USFS. Seventeen miles west of Swan Lake, MT. Timber. Active fire behavior with short crown runs, group torching and spotting. Numerous structures and infrastructure threatened. Evacuations, area and road closures in effect. Precipitation occurred over the fire area yesterday.

Doris Point, Flathead NF, USFS. Sixteen miles northeast of Kalispell, MT. Brush and timber. Active fire behavior with spotting, smoldering and short crown runs. Structures threatened. Area and road closures in effect.

Colt, Southwestern Land Office, Montana DNR. Transfer of command from CIMT (NR Team 5) back to the local unit will occur tomorrow. Twelve miles northwest of Seeley Lake, MT. Timber and brush. Minimal fire behavior with creeping and smoldering. Structures and communication infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

* **River Road East**, Lolo NF, USFS. CIMT (NR Team 1) mobilizing. Six miles southeast of Plains, MT. Timber

Predictive Services Discussion:

Some moderation is expected in the West with more substantial cooling over the Northern Rockies and more widespread showers and wet thunderstorms over the Great Basin. It will remain warm and dry over North Ops and much of the Northwest, but winds will decrease. Minimum humidity will still fall to 15% to 25% over a wide area, with some poor recoveries continuing in the midslopes and higher. Another round of isolated mixed wet and dry thunderstorms is expected over northern California, interior Oregon, and Idaho. As Hurricane Hilary begins to move closer to the US, scattered to widespread showers and wet thunderstorms are expected across southern California and western portions of the Four Corners states. However, New Mexico and Colorado will trend hotter and drier, and southerly winds will start to pick up as well. Hot and dry weather will continue over Texas, Oklahoma, and Louisiana. Further warming is also expected over the Plains states, with hotter and windier weather for much of the Mississippi and lower Missouri Valleys. It will remain cooler and mainly dry over the eastern Great Lakes and Northeast, while the Southeast will turn warmer and mostly dry aside from thunderstorms in Florida. Temperatures will remain near to below normal in most of Alaska, with showery weather over some interior portions of the state and some areas of breezy conditions.
