Flat, Rogue River-Siskiyou NF, USFS. IMT 1 (NW Team 3). Two miles southeast of Agness, OR. Brush and timber. Moderate fire behavior with backing, flanking and smoldering. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Bedrock, Willamette NF, USFS. IMT 2 (NW Team 13). Twelve miles south of Vida, OR. Timber, brush and grass. Active fire behavior with spotting, uphill runs and short crown runs. Structures threatened. Area, road and trail closures in effect.

Diamond, Tonto NF, USFS. IMT 2 (SW Team 3). Eleven miles west of Tonto Basin, AZ. Brush and grass. Active fire behavior with backing, flanking and running. Community of Sunflower, structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Cottonwood Ridge, Fort Apache Agency, BIA. IMT 2 (SW Team 5). IMT is also managing the Spoon incident. Four miles southwest of Show Low, AZ. Timber, brush and grass. Minimal fire behavior with backing, creeping

and smoldering. Area and road closures in effect. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

Spoon, Fort Apache Agency, BIA. Twenty miles southwest of Whiteriver, AZ. Chaparral, brush and grass. Active fire behavior with flanking, backing and torching. Area and road closures in effect.

Grapevine, Prescott NF, USFS. Eight miles east of Prescott Valley, AZ. Timber and brush. Minimal fire behavior with creeping and smoldering. Road closures in effect.

Guzzler, Apache-Sitgreaves NF, USFS. Twenty-six miles south of Winslow, AZ. Brush and grass. Minimal fire behavior with smoldering.

Predictive Services Discussion:

West-southwest sustained winds of 15-25 mph gusting 25-40 mph with minimum relative humidity of 6-20% will develop across portions of the western Great Basin and east of the Cascades into the Columbia Basin creating elevated to critical conditions. Breezy southwest winds will extend into the central Great Basin, while breezy south to southeast winds are also forecast across much of Texas. Hot temperatures will continue across southeast California through the greater Four Corners into much of the southern and central Plains and Southeast. Isolated to scattered mixed wet and dry thunderstorms will develop across the Southwest and greater Four Corners, with thunderstorms in the northern Rockies mainly near and east of the Divide. Thunderstorms, some severe, will develop from the northern and central Plains through the southern Great Lakes into the Mid-Atlantic ahead of a cold front, with isolated thunderstorms likely along the Gulf Coast and Southeast. Above normal temperatures and isolated thunderstorms will continue across much of the central and eastern Interior, with showers and cooler temperatures for southwest Alaska.
